Dear Chairman Shelby, Ranking Member Leahy, Chairman Frelinghuysen and Ranking Member
Lowey:

Given Congress has convened a lame duck session to resolve, among other pressing matters,
unfinished Fiscal Year (FY) 2019 appropriations bills, we are writing to urge that the **Census
Bureau receive \$4.456 billion in FY 2019.**

As you know, the Commerce, Science, Justice (CJS) appropriations bill, which funds the Census
Bureau, is one of the outstanding seven appropriations bills. The House and Senate
Appropriations Committees have approved their versions of the FY 2019 CJS bill, providing the
Census Bureau with \$4.799 billion and \$3.821 billion, respectively. The House bill, unlike the
Senate bill, directs \$1.6 billion of its total to be carried over and spent on 2020 Census activities
in the first quarter of FY 2020.

Throughout the FY 2019 CJS deliberations, census stakeholders have recommended Congress
provide the Bureau with at least at \$1 billion more than the Administration requested. The
Bureau needs this funding to not only sustain current 2020 Census operations and other key
census programs and surveys, but also to expand underfunded decennial census activities.

Census stakeholders suggest additional FY 2019 funding to:

Expand targeted communications activities (+\$100 million) — Additional targeted
advertising and promotion — the heart of the 2020 communications campaign — is necessary to
help boost response in the wake of the funding shortfalls and anxiety about the addition of an
untested citizenship question. Furthermore, the bureau should restore plans to launch early
communications activities targeting hard-to-count populations in FY 2019 and should provide
materials for an effective Statistics in Schools program. The Census Bureau has delayed the start

of the communications campaign from January 2019 to November 2019. This delay is short sighted and will leave the Bureau's state and local government and nonprofit partners without a national framework for their own plans to educate their constituencies about the importance and safety of census participation. State and local efforts are important, but the census is a federal responsibility, and the Census Bureau must take the lead in communications efforts.

Increase partnership staff from 1,500 to 2,000, and on-board them as soon as possible (+\$62.5 million) — Partnership specialists and assistants educate and mobilize states, localities, and community-based organizations in support of the census. These "trusted messenger" partners are especially critical in engaging hard-to-reach population groups, including persons with disabilities, low income rural and urban households, young children, people of color, LGBTQ individuals, and Native Americans. We have encountered numerous state and local officials and nonprofit/civic leaders who are organizing now to support the 2020 Census, and they do not have access to sufficient Partnership Program staff to assist them. The Census Bureau recently increased its peak Partnership Specialist hiring goal from 1,000 to 1,500, but it did not request additional funding and is not recruiting, hiring, and onboarding these staff soon enough to be sufficiently helpful to the network of partners the bureau will need to ensure a successful census. For the 2010 Census, the bureau hired 3,000 partnership staff. Our recommendation moves the 2020 Census program closer to the 2010 level of effort, as appropriators directed in both FY 2018 and FY 2019 report language and supports more timely hiring of a mix of partnership staff to ensure a robust, early partner engagement effort.

Expand the bureau's "field footprint" by adding Questionnaire Assistance Centers (QACs) during peak operations (\$32.9 million) — The 2020 Census plan calls for half the number of Regional Census Centers and Area (local) Census Offices compared to the 2010 Census and no QACs, which helped people complete their forms voluntarily in 2010. The significantly reduced field presence is simply insufficient given the Commerce Department's lower projected self-response rate (as low as 55%) and new threats to full participation after that projection was developed. Stakeholders previously recommended increasing the number of local offices from 248 to 300 (at a cost of +\$312 million), but it is likely too late for the Census Bureau to implement such an increase now. Instead, we recommend funding cost-effective QACs, where people can receive in-person help with completing their online or paper forms from trusted community representatives sworn to confidentiality by law and trained by the Census Bureau. There were approximately 30,000 QACS open part-time and staffed by one or more trained Census Bureau employees during peak 2010 operations at a cost of \$27.3 million (\$32.9 million in 2020 dollars). For 2020, QACs could open during peak operations in places like libraries, community and senior centers, places of worship, and state and local government agencies.

Finally, to ensure robust and uninterrupted ramp-up, preparations, and early peak operations, we urge Congress (1) to **advance fund** all or part of the FY 2020 appropriation for the 2020 Census in the FY 2019 bill, which would not count against the FY 2019 budget cap; and (2) to **approve requests for additional spending** in FY 2019 on vital activities based on identification of real-time risks and emerging threats to a successful census.

In sum, as you work to resolve details regarding the final FY 2019 CJS bill, we ask you to:

1. Provide the Census Bureau with at least \$4.456 billion in FY 2019, ensuring that of this amount, \$3.648 billion is spent on 2020 Census activities.
2. Provide enough funding in FY 2019 for the Census Bureau to carry out the expanded partnership, communications, and field operations efforts discussed in the Senate Appropriations Committee report accompanying the Commerce, Justice, and Science bill (S. Rept. 115-275) and supported by census stakeholders.
3. Ensure that the Census Bureau has sufficient funding at the start of FY 2020 — including certainty of its full-year funding level through an advance appropriation, if possible — to begin implementing a full 2020 Census program, *without shortchanging the bureau in FY 2019*, the critical final year of preparations.

Thank you for considering our requests and for your hard work negotiating a final FY 2019 CJS spending bill.
